

**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING  
THE CALL FOR BIDS FOR THE MARIN AVENUE PAVEMENT AND CURB  
RAMP REHABILITATION PROJECT – PHASE 2 (CIP NO. 23004)**

**WHEREAS**, on November 16, 2020, the City Council adopted Resolution No. 2020-108 adopting the FY2019/20 – FY2023/24 Capital Improvement Plan (CIP) and appropriating funding for the first three years of the plan, including budget for the Annual Street Rehabilitation Program (CIP No. 21000); and


**WHEREAS**, on July 18, 2022, the City Council adopted Resolution No. 2022-105 approving stormwater drainage improvements for the Marin Avenue Pavement and Curb Ramp Rehabilitation Project – Phase 2; and

**WHEREAS**, on June 17, 2024, the City Council adopted Resolution No. 2024-49 approving high priority improvement to intersection safety lighting and improvements to existing traffic signal infrastructure into a revised set of plans and specifications for the Marin Avenue Pavement and Curb Ramp Rehabilitation Project – Phase 2; and

**WHEREAS**, on December 5, 2024, the Transportation Commission recommended that the City Council approve the Marin Avenue Pavement & Curb Ramp Rehabilitation Project – Phase 2; and
