

**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING  
THE CITY MANAGER TO EXECUTE CHANGE ORDER #1 TO  
CONTRACT NO. C25-05, APPROPRIATING FUNDS FROM ALAMEDA COUNTY  
TRANSPORTATION COMMISSION MEASURE B FUNDS, ACCEPT  
THE IMPROVEMENTS COMPLETED UNDER CONTRACT NO. C25-05  
FOR THE 2025 BUCHANAN STREET REPAIR PROJECT (CIP NO. 21000), AND  
AUTHORIZING STAFF TO FILE THE NOTICE OF COMPLETION**

**WHEREAS**, the project is now complete and a Notice of Completion is required to be filed with the County Recorder's Office; and

1       **WHEREAS**, Alameda CTC Measure B collection expired in 2022, and timely use of  
2 funds policies require that all Measure B Direct Local Distribution fund balances be spent by  
3 June 30, 2026.

5       **NOW, THEREFORE, BE IT RESOLVED**, that the Albany City Council hereby  
6 authorizes the City Manager to execute Change Order #1 to Contract No. C25-05 in the amount  
7 of \$101,876.55; and

9       **BE IT FURTHER RESOLVED**, that the Albany City Council hereby appropriates  
10 \$135,457 from Alameda CTC Measure B Local Streets and Roads funds and \$18,831 from  
11 Alameda CTC Measure B Bicycle & Pedestrian funds to the Annual Street Rehabilitation  
12 Program (CIP No. 21000); and

14       **BE IT FURTHER RESOLVED**, that the Albany City Council hereby accept the  
15 improvements completed in Contract No. C25-05 and file the Notice of Completion with the  
16 Alameda County Recorder's Office.
