WHEREAS, The Alameda County Transportation Commission (Alameda CTC) conducted a multi-year corridor planning effort for the San Pablo Avenue corridor that concluded in 2022; and

WHEREAS, within Albany, the San Pablo Avenue Parallel Bike Improvements project includes improvements at two intersections, Kains Avenue/Solano Avenue and Kains Avenue/Marin Avenue; the work at these intersections includes crossing treatments to assist cyclists traveling along the Kains Avenue two-way bikeway in crossing these streets; and

WHEREAS, Alameda CTC developed conceptual designs and sought public input on the proposed project concepts from 2022 through 2023; and

1 **WHEREAS**, the Albany City Council approved conceptual designs for the Safety
2 Enhancements and Parallel Bike Improvements projects at the July 17, 2023 Council meeting;

5 **WHEREAS**, since summer 2023, Alameda CTC has secured external funding for
6 construction including federal One Bay Area Grant funds and local Measure BB funds,
7 certified a CEQA Categorical Exemption and a NEPA Categorical Exclusion, and finalized the
8 project Plans, Specifications, and Estimates for the San Pablo Avenue Parallel Bike project;
9 and

11 **WHEREAS**, the Albany Transportation Commission reviewed designs for the San
12 Pablo Parallel Bike Improvements project at its March 26, 2026 meeting, where the
13 Commission provided additional comments and recommended that Council authorize
14 issuance of an encroachment permit to Alameda CTC's construction contractor.
15

16 **NOW, THEREFORE, BE IT RESOLVED**, that the Albany City Council hereby
17 approves the plans for construction of the San Pablo Avenue Parallel Bike Improvements
18 Project within Albany and directs the City Manager to instruct staff to proceed with issuance
19 of an encroachment permit to the Alameda County Transportation Commission and their
20 designated contractor for installation of the improvements specified in the plans.
