**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING
THE CITY MANAGER TO SUBMIT THE JEWEL'S TERRACE PARK TENNIS
COURT AND MEMORIAL PARK TENNIS COURT RECONSTRUCTION AND
RESURFACING PROJECTS FOR A UNITED STATES TENNIS ASSOCIATION
GRANT, ENTER INTO A GRANT AGREEMENT, AND
EXPEND GRANT FUNDS IF AWARDED**

WHEREAS, on July 7, 2025, the City Council adopted the Capital Improvement Project (CIP) Plan, which programs and budgets for an implementation roadmap for capital renewal of and enhancements to the City's infrastructure, parks, and facilities; and

WHEREAS, as part of the adoption of the CIP Plan, the City established the Annual Parks Rehabilitation Program (CIP No. 41000), which formalizes a committed annual capital investment into the City's parks infrastructure; and

WHEREAS, the United States Tennis Association (USTA) offers competitive grant funding to tennis facilities that are open to the public in the amount of up to 50% of the total project cost for projects of various complexity; and

WHEREAS, matching grant funding would allow the City to expand the scope of the planned Jewel's Terrace Park Tennis Court and Memorial Park Tennis Court Reconstruction and Resurfacing Projects under the Annual Parks Rehabilitation Program, and provide a more comprehensive refresh to these high-use facilities.

NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council does hereby authorize the City Manager to submit a grant application to the USTA Grant Program for the Jewel's Terrace Park Tennis Court and Memorial Park Tennis Court Reconstruction and Resurfacing Projects and enter into a grant agreement with USTA if awarded, and appropriates grant funds awarded for expenditure on the projects under the Annual Parks Rehabilitation Program (CIP No. 41000).
