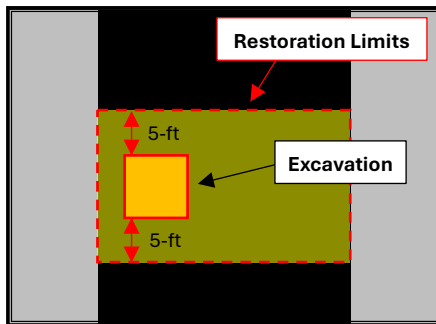


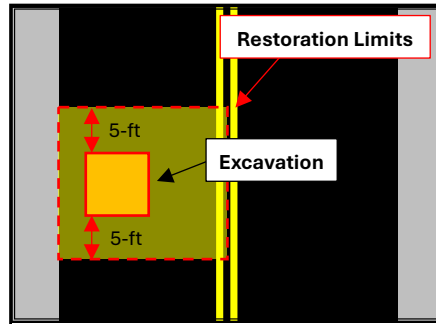


Excavation Moratorium – Street Restoration Requirements

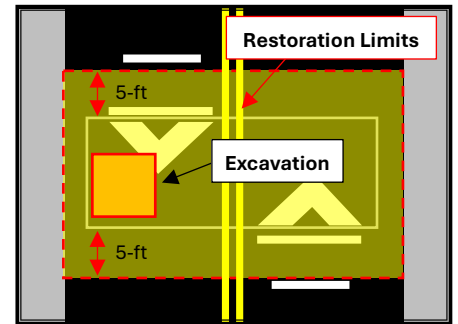
Restoration on streets under an excavation moratorium must adhere to the following requirements as described below in addition to conformance with City Standard Details.



Restoration limits on a street without a continuous centerline



Restoration limits on a street with a continuous centerline



Restoration limits on a street with a speed hump/table

Slurry Seal Streets

- After standard site restoration, a slurry seal treatment must be conducted. 2-in grind & overlay may be substituted for a slurry seal treatment.
- Slurry seal shall extend a minimum 5-ft in each longitudinal direction of the trench/excavation limit and:
 - Where there is no continuous centerline, must be curb-to-curb in width; **or**
 - Where there is a continuous centerline, must be conducted curb-to-centerline in width.

Grind & Overlay Streets

- A minimum 2-in depth grind & overlay is required; it must extend a minimum 5-ft in each longitudinal direction of the trench/excavation limit and:
 - Where there is no continuous centerline, must be curb-to-curb in width; **or**
 - Where there is a continuous centerline, must be conducted curb-to-centerline in width.
- Where a speed hump/table is impacted, the longitudinal direction must include the entirety of the speed hump/table, 5-feet in each longitudinal direction, and curb-to-curb in width regardless of whether a continuous centerline is present.
- Grind & overlay depth is at the discretion of the Public Works Department and a deeper section may be required depending on site and cross-section conditions.

Excavation Moratorium – Street Restoration Requirements

Reconstructed or Cold In-Place Recycled Streets

- Coordinate directly with the Public Works Department.
- Expect to adhere to Grind & Overlay Streets requirements, at minimum, in addition to conditions set forth directly via Public Works Department coordination.
 - Additional requirements may include, but are not limited to, full depth pavement restoration and controlled low strength material backfill.
